NOTICE INVITING TENDER

Tender for Drugs, Diagnostic Rapid Kits, Surgical Items and Supporting Miscellaneous Items in Category –A, Category-B, Category-C and Category-D

Patna Medical College and Hospital, Patna is a 1675 bedded hospital with an occupancy rate of more than 95% having all Specialty with 8 intensive Care units catering to need of People of Bihar neighbouring State and countries. To ensure good Quality Healthcare PMCH is aiming towards rational drug management and Procurement to ensure Good Quality drugs and Services as per the gaudiness of Government .

Bids are invited from Interested Manufacturers / Direct Importers to Supply essential and other important Drugs, Diagnostic Rapid Kits, Surgical Items and Supporting Miscellaneous Items for the year 2016-17. Details of Drugs, Diagnostic Rapid Kits, Surgical Items and Supporting Miscellaneous Items can be available from the office of Superintendent, Patna Medical college & Hospital, Patna during office Hours or on website – www.prdbihar.org, www.prdbihar.gov.in and www.pmch.in .

Minimum Eligibility Criteria :- Bidder Should meet the following criteria to be eligible for bidding for category – A, B, C and D.

- (a) Tender bid is invited for **Drugs, Diagnostic Rapid Kits, Surgical Items and its Supporting Miscellaneous Items** for the eligible interested Manufacturer / Direct Importer only. Tender Bid is Invited Directly from Manufacturers / Direct Importer only. Distributors/Agents/Loan Licensees/Contract Manufacturers are not eligible to Participate in the tender. Manufacturers/Direct Importer, which have been blacklisted / De-registered / De-Barred by any Government Institutions / Organization in India are barred for Participating in this tender . Their Bids will not be Considered.
- (b) Manufacturer / Direct Importer must have minimum 3 years Old Manufacturing License of the Quoted Product up to last date of Tender Submission with Latest License Renewal Certificate and Approved Product list . In case of Importer, The Importer Firm must have minimum 3 Years Old Valid Import license of the Quoted product and Proof of Import and Sale of these product in India by the Importer Firm. For Category – ‘B’ the Importer must be registered by Central Drug Standard Control Organizations in Form -41 under Rule 27A of Drug & Cosmetic Act 1945 for IVD Products only .
Manufacturing License / Import License must be valid on the Last Date of Submission of the Tender .
- (c) Manufacturer / Direct Importer must have market Standing in India of Minimum Three Years, issued by the Concerned Licensing Authority for Drug Control Department or Any relevant Govt. Authority for Only Category – ‘A’ ‘B’ and ‘C’ .
Excluding new molecules formulation.

- (d) WHO GMP / GMP / COPP Certificate for the manufacturing Unit for the Category – ‘A’ ‘B’ and ‘C’. For category ‘D’ products valid ISI/ ISO/CE/BIS etc. Certificates, Whichever is applicable to be Submitted.
- (e) Copies of the audited Balance Sheet and profit & loss statement showing details of their Annual average Turnover of the Manufacturer / Direct Importer Should be minimum Rs. – 25 (Twenty Five) Crores, for Category – ‘A’ and ‘B’ & Rs. – 5 (Five) Crores for Category – ‘C’ and Rs. – 1 (One) Crores for Category – ‘D’. Annual average Turnover for any three of the last four Consecutive financial Years between 2012-13 to 2015-16, issued by Registered C.A. bearing his Registration Number .
- (f) Upto Date non Conviction Certificate of Manufacturer Direct Importer issued by the Licencing Authority of Drug Control Department under Drug and Cosmetic Act 1940 and the Rules 1945 for Category – ‘A’, ‘B’ and ‘C’. If validity Date is not mentioned in the Non-Conviction Certificate, it must have been issued within 12 Months/ one year from Last Date of Submission of Tender . For Category – ‘D’ An Affidavit sworn before the First Class Magistrate Stating That (1) **“The Company / Firm has not been Blacklisted / De-Registered / De-Barred by any Govt. Institutions/ Organizations in India and shall also Mentioned Full Name and Address with Telephone/ Fax/Mobile Number in the Affidavit”** .
(2) **“The Company Or Any Officer of the Company has not been ever Convicted under Relevant Act and Rules”** .
(3) **“ Its quoted product is not black listed currently (as on the date of submission of the tender) by central Government / central Government agencies / any state Government or any of the state Government agencies / or any Drug Procurement agencies or any other Drug Procurement Corporations.”**
- (g) Copy of Income Tax Return for any 3 (Three) Assessment Years of Last four Consecutive Assessment Years between 2013-14 to 2016-17 for Manufacturing / Importer (Self Attested).
- (h) Photocopy of PAN Card of Manufacturing Company/ Importer should be Submitted (Self Attested).
- (i) Manufacturer / Direct Importer will be required to Deposit EMD in form of Demand Draft / Banker’s Cheque in Favour of Superintendent, Patna Medical college & Hospital, Patna of Rs.- 1,00,000/- (One Lacs) for each Category – ‘A’, ‘B’, ‘C’ and ‘D’ Rs.- 50,000/- (Fifty Thousand) .

Submission Requirement :-

Interested eligible Company wishing to bid, May Submit their Tender in Large Envelope Marked – “Tender of Drugs Category – ‘A’”. This large Envelope Contains Two Separate Sealed Envelope – “One Marked TECHNICAL BID For Category ‘A’ and another Marked Financial Bid for Category ‘A’”. Similarly for Category ‘B’, ‘C’ and ‘D’, Bid Must be submitted in a Separate Envelops Marked accordingly like above . The Technical and Financial Bid should be Submitted in Performa –A and B respectively. Any other format will be treated as non-responsive.

Note:- (For All Category Bidders A, B, C and D) –

1. Mention the names of Drug / Item along with Sr. No. of the Tender Product List for Which you are Bidding (as per Performa – A) and relevant Paper should attached . The relevant Page No. must be mentioned on the Check List Also.

2. Bidders are Required to submit separate Bids for each Category .
3. Bidders are required to submit Separate EMD for each Category.
4. Technical Bids not accompanied by Earnest Money or any of the above mentioned Documents shall be rejected .
5. All Documents are attested by Bidder with seal and an Affidavit in original Copy stating That **“If at any stage comes to notice of PMCH for any sources that submitted document in bid is false/fake/ fabricated. The PMCH reserve the right to verify it and If it found that True the Earnest Money of the said Party shall be forfeited and Legal Processing against the Bidder shall be initiated as per Law .”**
6. Bidder of All Category shall submit an Affidavit in Original Copy stating That **“If at any stage comes to notice of PMCH for any Sources that Manufacturer / Importer is Blacklisted / De-registered/ De-Barred has cancelled the Facts . The PMCH reserve the right to verify it and If it found that True the Earnest Money of the said Party shall be forfeited and Legal Processing against the Bidder shall be initiated as per Law .”**
7. Bidder shall Quote only single Rate for One Product / Item . If the rate of More than the Single for the same product / item than the rate of the Product will be not considered.

You are requested to clearly indicate by index each of the submission requirements mentioned in cover A and cover B along with relevant page number in your cover letter/ application accompanying the technical proposal.

FINANCIAL BID :-

1. Rates (Inclusive of packing & forwarding, Sales Tax, Excise Duty, Customs duty, transportation, handling, loading & unloading, insurance, and any incidental charges) should be quoted for each drug “ on door delivery basis” in the format given in price bid. Conditional bid shall not be accepted.

2. In case of discrepancy in “In Figure” price and “In Words” price than “In words” price would prevail .
3. For all categories an affidavit has to be given in Financial Bid Envelope that “The rate Quoted (inclusive VAT & other libel Taxes) in the financial bid is at least 20% less than the MRP.
4. Quoted Rate of the Drug must not exceed the selling price as fixed by NPPA as per the Provision of DPCO and An Affidavit before the first class magistrate to this effect must be enclosed with financial bid and also mentioned in above affidavit (1) **“The Quoted rate is this Financial Bid is Not More than the rate Quoted is any other Government Organization/ institutions for Supply.”** (2) **“ The Quoted Rate is this Financial Bid is more less then 20% of MRP.”**
5. Price list in Form-V as per provision of DPCO for Drug Item and Price List/MRP List/ Trade Price List for Another Item must be enclosed with the financial Bid.
6. Rate Quoted shall be inclusive of VAT and all other Taxes as per “Performa – B”.

7. Each page of the Financial Bid should be Duly Signed and Sealed by the Tenderer .
8. In Case of Non-Submission of any one or all of the above Financial Bid will be not considered .

Tender Conditions:

- i.** The tab/Cap./bottle etc. should have mark of “HOSPITAL SUPPLY/GOVT. SUPPLY-NOT FOR SALE”.
- ii.** Samples of Supplies in each batch will chosen for testing by Government of Bihar notified laboratories.
- iii.** The Bidder shall Submit the certificate of analysis from an NABL Accredited Drug Testing Laboratory/ Central Drug Laboratory/In House Quality Control Laboratory with necessary protocols for every batch of items supplied along with the consignment. Blood products should be supplied along with HIV and Hepatitis-B Screening Certificate, Failing which the items will not be accepted.
- iv.** Drugs / item should be supplied within 45 days after issued order.
- v.** However, the Tender Inviting Authority may receive supply even after expiry of the scheduled date from the date of purchase order, at its discretion, considering the urgency of

the essential item for the user Institutions and in such case, liquidated damages will be levied at 0.5% per day of the value of the delayed supply subject to a maximum of 10% (20 Days). Then after purchase order shall be Treated cancelled.

vi. The Supplied Drugs must have 85% of Shelf life period in accordance with Schedule P of Drugs and Cosmetics Rules, 1945 and in case of vaccine and cold chain product minimum shelf life period must be 75% as per the Schedule P of Drugs and Cosmetics Rules, 1945.

vii. If the product fails in quality test, the entire batch will be taken back by the supplier at the supplier's cost and the hospital shall not be responsible for any damage during this period.

viii. Leaked, soiled, broken containers with damage labels shall not be accounted for the purpose of supply. Labelling on strips/vials/ampoules/IV. Fluids/boxes/cartons and other items should be clear and legible. Labels should be well stuck on to the container. If not, the supply may be rejected.

ix. The inner label as well as label on the catch cover/ carton shall bear conspicuously the words, "HOSPITAL SUPPLY/GOVT. SUPPLY-NOT FOR SALE" and bolder than those already printed/Stamped on the label. The above caption shall run from the lower left corner to the top right hand corner.

x. Bidder should quote one rate for one product.

xi. The rate contract will be applicable for the one year or discretion of Purchase Committee/Tender inviting authority.

xii. All Affidavit submitted by the first class Magistrate in original copy in each and every tender.

xiii. If the awarded supplier is unable to meet the fully supply at the L¹ rate in given time frame, the award can be given to L² / L³ bidders by decision of purchase committee.

xiv. The Tenderers should quote the rates for the generic products only. The composition and strength of each product should be as per specifications given in list.

xv. The Tender Inviting authority reserves the right to accept/reject/cancel or defers the tender submitted for any / all items or tender.

Deadline for Submission of Proposal:

The technical and financial bid in separate sealed envelopes must reach the office of the undersigned within 21 (Twenty One) days of the publication of the tender by Registered post/ Speed Post. In no circumstances the tender will be accepted by hand/Courier.

Opening of Bids:

Technical Bid will be opened in next working day at 12.30 PM in "Superintendent Office" in presence of Purchase Committee after submission date of this tender. Bidders or Their Authorized Representative are may be present in the Meeting at that Time and Date.

Financial bid of those parties will be opened who qualify in technical bid. The decision of the Purchase Committee of Patna Medical College & Hospital, Patna will be final. The committee reserves the right to cancel the bid at any time without assigning any reason. For further enquiries contact Superintendent Office during office hours on working days.

After being awarded the contract, the awardees will be required to be registered with the Bihar Sales Tax if not registered. The selected Company/ Firm will be immediately informed about the final award. In case the selected Company Firm declines to take up the task at the quoted and approved rates, it would be barred from applying for any tender from PMCH, Patna and will be recommended for black listing by Govt. of Bihar. Also the tender/Security money will be forfeited. Any matter according to dispute leading to court case will be within preview of Patna district only.
